Drop Policy To drop from an ELI class, a drop request must be submitted in person to the office by the first Friday of the session to avoid a tuition charge.

Refund Policy 100% of tuition is refunded if the class is dropped by the first Friday of the session.
NO TUITION REFUND FOR CLASSES DROPPED AFTER THE FIRST FRIDAY.

Delinquent accounts will be referred to a collection agency and a collection fee will be added to the original balance. A registration and transcript hold is placed until account is paid in full with guaranteed funds. Delinquent accounts will be referred to the state Finder program which places a lien on your state tax refund for seven years.
