

## LETTER OF AGREEMENT

Party A: Agent

**Party B:** The University of Utah, a body politic and corporate of the State of Utah, and an institution of higher education, on behalf of its department of Continuing Education, English Language Institute, with a notice address of: University of Utah, Continuing Education & Community Engagement, Korrin Ebira, Director, 1901 East South Campus Drive, Room 2202, Salt Lake City, Utah 84112 (telephone number: 801-581-4600, and fax number: 801-585-9449).

To promote the advancement of international understanding, dissemination of learning, and development of language instruction, and to fulfill the mission of the English Language Institute, **Agent** (hereinafter referred to as Party A) and the University of Utah, a body public and corporate of the State of Utah and an institution of higher education in the U.S.A., on behalf of its Continuing Education English Language Institute (hereinafter referred to as Party B) agree as follows regarding the plan to recruit eligible students to attend ESL classes at the University of Utah, U.S.A., in accordance with the following provisions.

- 1. Party A will be responsible for:
  - A. Recruiting the prospective students
  - B. Providing the English Language Institute with necessary information about the prospective students for purposes of preparing the necessary government immigration documents, registration forms, orientation materials
  - C. Providing accurate information about the program and about housing options and insurance and the fact that students who are sent by agents are not eligible for any ELI tuition discounts.
  - D. Invoicing Party B on company letterheads for the recruitment fee of \$300 per student WITHIN 60 DAYS after student has registered and paid for their FIRST session.
  - E. Reading and following the ethical guidelines for agents as written by NAFSA: Association of International Educators
- 2. Party B will be responsible for:

D . A

- A. Administering, coordinating, and providing an intensive, full-time ESL program for the prospective students. All the instructors are certified instructors in TESOL or ESL.
- B. Orienting and placing the student in appropriate level classes and evaluating and advising the students on their progress at the end of each session.
- C. Providing access to normal university facilities such as the library, computer labs, public transportation, digital language lab, etc some of which may require additional fees.
- D. Issuing a Certificate of Completion to each qualified student at the end of the program.
- E. Paying Party A, upon receipt of the Party A's invoice, the recruitment fee of \$300 per student after payment of student tuition for the second session attending.
- 3. This Agreement applies is not an affiliation agreement between Party A and Party B. Any amendments and supplements to this Agreement during the period of execution shall be dealt with through friendly consultation between the two parties confirmed by exchange of memorandums.
- 4. This Letter of Agreement may be renewed annually by mutual agreement in writing.
- 5. Either party shall be excused from performance under this agreement or at such party's discretion by written notice if performance under this agreement is prevented by circumstances outside of its control, including but not limited to, international travel restrictions or public safety or security concerns. If this agreement is terminated for such a reason, Party B shall promptly refund any monies it previously received from trainees, less all reasonable costs and expenses previously incurred by Party B in connection with this agreement prior to such termination, such as, but not limited to, prepaid travel expenses and Party A will promptly refund any monies it previously received for recruiting trainees.
